### Part A: Pupil premium strategy plan

#### Statement of intent

At St. Patrick's Catholic Voluntary Academy we target the use of Pupil Premium Grant funding to ensure that our disadvantaged pupils receive the highest quality of education to enable them to become active, socially responsible citizens of the future. We recognise that disadvantaged children can face a wide range of barriers which may impact on their learning. By using this funding, our aim is to:

- Remove barriers to learning created by poverty or family circumstance
- Narrow the attainment gaps between disadvantaged pupils and their nondisadvantaged counterparts both within school and nationally
- Ensure ALL pupils are able to read fluently and with good understanding to enable them to access the breadth of the curriculum
- Develop confidence in their ability to communicate effectively in a wide range of contexts
- Enable pupils to look after their social and emotional wellbeing and to develop resilience
- Access a wide range of opportunities to develop their knowledge and understanding of the world and increase their cultural literacy

#### Achieving our objectives:

In order to achieve our objectives and overcome the identified barriers to learning we will:

- Provide all teachers with high quality CPD to ensure that pupils access effective quality first teaching
- Provide targeted personalised intervention and support to quickly address identified gaps in learning
- Target funding to ensure that all pupils have access to trips, residentials and first-hand learning experiences
- Provide opportunities for all pupils to participate in enrichment activities including sport and music
- Provide appropriate pastoral support to enable pupils to access learning within and beyond the classroom

#### **Key Principals:**

We will ensure that effective teaching, learning and assessment meets the needs of all pupils through the rigorous analysis of data. Class teachers will identify need and plan specific interventions and support for individual pupils which will be reviewed in termly Pupil Progress meetings. Alongside academic support, we will ensure that those pupils who have social, emotional and mental health needs will access high quality provision from appropriately trained adults.

# Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challen ge number	Detail of challenge
1	Social, emotional and mental health School referrals for SEMH support are increasing and our assessments, observations and discussions with pupils and families indicate that the wellbeing of our disadvantaged pupils has been negatively impacted to a greater extent than for other pupils. 11 pupils are now recorded as having SEMH as their primary Special Educational Need. Of these 11 pupils, 73% are disadvantaged.
2	Gaps in reading, writing, maths and phonics Internal and external assessments indicate that, in some subjects and year groups, there is an attainment gap between our disadvantaged and non-disadvantaged pupils.  (Please see Part B: Review of the previous academic year, Outcomes for disadvantaged pupils, page 10)
3	Speech, language and communication  Assessments, observations and discussions with pupils indicate underdeveloped oral language skills and vocabulary gaps among many disadvantaged pupils. These are evident from Nursery through to KS2.
4	Attendance and punctuality  Attendance data indicates that, as of November 2024, of our 'persistently absent pupils' 20.7% were disadvantaged whereas our non-disadvantaged pupils accounted for 16% of our PA pupils.  Punctuality is also an issue for some with 2.1% of disadvantaged pupils recorded as late compared to 0.93% of non-disadvantaged pupils. (Nov 24)
5	Access to wider opportunities  Research on children from disadvantaged backgrounds also shows they have less access to wider experiences including reading for pleasure materials, access to wider trips and learning <a href="https://clpe.org.uk/system/files/CLPE%20Reading%20for%20Pleasure%202021_0.pdf">https://clpe.org.uk/system/files/CLPE%20Reading%20for%20Pleasure%202021_0.pdf</a>
6	Parental engagement  We are cognisant of the barriers to engagement faced by some of our parents. They include costs, time and transportation, language (for some parents for whom English is not a first language), low levels of literacy and numeracy and a lack of confidence in supporting children's learning or engaging with a school.

# Part B: Review of the previous academic year

#### **Outcomes for disadvantaged pupils**

#### GLD

38.5% of non-disadvantaged pupils achieved a Good Level of Development in the 2023-24 academic year compared with 0% of disadvantaged pupils.

#### **Year 1 Phonics Screening Check**

66.7% of our disadvantaged pupils met the expected standard compared with 47.6% of our non-disadvantaged pupils.

#### Key Stage 2

Disadvantaged pupils performed better than non-disadvantaged pupils in Reading. The disadvantage gap index is down from 3.21 in 2023 to 3.12 in 2024.
